

**Php 2.164 Million**  
**Released for Barangay Officials Death Benefits**  
For the Month of September 2012

The Department of Budget and Management (DBM) has released to the Department of the Interior and Local Government the amount of **Two Million One Hundred Sixty Four Thousand Pesos (Php 2,164,000.00)** to settle the claims of the beneficiaries of **157** deceased barangay officials for the month of September 2012. Of the number, **28** are Punong Barangays (PB), **108** are Sangguniang Barangay Members (SBM), **8** are Barangay Secretaries (BS), **10** are Barangay Treasurers (BT) and **3** are Sangguniang Kabataan Chairmen.
