- Forum where disputes could be amicably settled

III. POWERS OF THE BARANGAY

- As a government entity, a barangay has power to tax, police or regulatory power, and power of eminent domain. It can take over private property if public interest so demands, by compensating the owner
- As a Public Corporation, it can increase its resources and build equity through prudent management. It may invest part of its income. It may borrow from financial institutions. It may create enterprises, acquire or sell property, forge ventures with public or private investors, even lend money. In other words, it may do what other corporations do

IV. TERM OF OFFICE OF BARANGAY OFFICIALS

- 3 years in the same position
- Voluntary renunciation of office for any length of time shall not be considered as an interruption in the continuity of service for the full term for which the elective official was elected

V. POWERS OF THE PUNONG BARANGAY

- Promote the general welfare of the barangay
- Enforce all laws and ordinances within the barangay
- Negotiate, enter into, and sign contracts for and in behalf of the barangay, upon authorization of the Sangguniang Barangay
- Maintain public order in the barangay
- Call and preside over the session of the Sangguniang Barangay and the Barangay Assembly. and vote only to break a tie
- Appoint or replace the appointed barangay officials
- Organize and lead an emergency group whenever the same maybe necessary for the maintenance of peace and order or on occasions of emergency or calamity within the barangay
- Prepare the annual executive and supplemental budgets of the barangay
- Approve vouchers relating to the disbursement of barangay funds
- Enforce laws and regulations relating to pollution control and protection of the environment
- Administer the operation of the Katarungan Pambarangay

- Exercise general supervision over the activities of the Sangguniang Kabataan
- Ensure the delivery of basic services as mandated under Sec. 17 of the RA 7160

3. PAMAMAHALA NA MAY PANANAGUTAN (Accountability)

- Ginugugol ang 20% ng IRA sa wastong pamamaraan alinsunod sa mga umiiral na batas at pamantayan

VII. BASIC SERVICES AND FACILITIES IN THE BARANGAY

- Agricultural support services which include planting materials distribution system and operation of farm produce collection and buying stations
- Health and social welfare services which include maintenance of barangay health center and day-care center
- Services and facilities related to general hygiene and sanitation, beautification, and solid waste collection
- Maintenance of katarungang pambarangay
- Maintenance of barangay roads and bridges and water supply systems
- Infrastructure facilities such as multi-purpose hall, multipurpose pavement, plaza, sports center, and other similar facilities
- Information and reading center
- Satellite or public market

VIII. SOURCES OF INCOME OF THE BARANGAY

- Barangays are authorized to generate income from taxes on stores or retailers with fixed business establishments and gross sales or receipts in the preceding year of P50,000 or less in cities and P30,000 or less in municipalities at the rate not exceeding one percent (1%) on such gross sales or receipts

- Service fees or charges for the use of barangay property or facilities
- Barangay clearance fees
- Fees or charges for the commercial breeding of fighting cocks and on cockpits and cockfights
- Fees or charges on places of recreation with admission fees
- Fees or charges for billboards, sign boards, neon signs and other outdoor advertisements
- Toll fees or charges for the use of any public road, pier or wharf, waterway, bridge, ferry, or telecommunications system funded and constructed by the barangay
- Revenues from the operation of public utilities and barangay enterprises (markets, slaughterhouses, etc.)
- Fines (not exceeding P1,000) for the violation of barangay ordinances
- Proceeds from the sale or lease of barangay property or from loans and grants secured by the barangay government
- Real property tax (RPT) collections of the province and city
- Community tax collections when collected by the barangay
- Internal revenue collections
- The development and utilization of the national wealth
- The proceeds of tax on sand, gravel, and other quarry sources
- Tobacco excise tax pursuant to RA No. 7171

Share from Real Property Tax (RPT)

- In the case of provinces, twenty-five percent (25%) of the proceeds from RPT collections of the province shall accrue to the barangay where the property is located.
- In the case of cities and municipalities within the Metropolitan Manila Area, thirty percent (30%) of the proceeds shall be distributed among the component barangays within the city/municipality where the property is located, as follows:
 - ◊ 50% to the barangay where the property is located; and
 - ◊ 50% to be distributed equally among all component barangays of the city/municipality

Share from national wealth utilization

- A barangay is entitled to thirty-five percent (35%) of the forty percent (40%) share of the province or highly urbanized or independent component city where it belongs. If the natural resources are located in two (2) or more barangays,
 - ◊ Population - 70%
 - ◊ Land area - 30%

Share from IRA

- Barangays get 20% of the total IRA which is divided among each one of the 42,028 barangays based on the following formula:
 - ◊ Population - 60%
 - ◊ Equal Sharing - 40%
