PROJECT OVERVIEW

Chapter VII of the Philippine Development Plan of 2011-2016 underlines the promotion of effective and honest governance creating an enabling environment for citizens and the private sector to reach their full potential. The Performance-Based Incentive Policy (PBIP) of the Development Budget Coordinating Committee (DBCC) issued on February 20, 2009 provides an incentive framework to rationalize intergovernmental transfer to LGUs, while the Presidential Directive of January 2011 issued by the Office of the President mandates NEDA, DILG, DA and DTI to create a system of incentives and disincentives to ensure that LGU projects are aligned with national priorities. Thus was born in 2010 the Performance Challenge Fund to provide LGUs with a counterpart fund to finance high-impact local development projects that are consistent with both the Annual Investment Program (AIP) and national goals and thrusts.

The PCF initially used as one of the criteria the Seal of Good Housekeeping (SGH), an assessment that LGUs must exceed to qualify to the PCF. Since its inception, the DILG, through the Bureau of Local Government Development (BLGD), has been continuously implementing and monitoring the PCF-assisted projects together with their corresponding subsidies for LGU-beneficiaries. Subsequently, the SGH was upscaled in 2014 into the Seal of Good Local Governance (SGLG) which raised the bar of excellence for qualified LGUs.

PCF INCENTIVES DRIVE GROWTH & DEVELOPMENT

Now on its fifth year of implementation, the Performance Challenge Fund rewards LGUs with a subsidy so they can execute high-impact development projects reflected in the Annual Investment Program of LGUs.

In general, PCF aims to recognize good governance performance in matters of transparency and accountability, planning and fiscal management, efficiency in the delivery of services, and responsiveness to the public and link with incentives and grants.

Concretely, PCF supports LGUs in the implementation of projects to: (1) achieve the Millennium Development Goals (MDGs), (2) maintain core road network to boost tourism and local economic development, (3) comply with Philippine Disaster Risk Reduction and Management Act of 2010 and Climate Change Adaptation, and (4) support the Ecological Solid Waste Management Act of 2000. All proposed projects must be implemented and completed within one year.

These projects drive good local performance and encourage people participation and involvement in processes that fuel a change in the local governance practices.

RAISING THE BAR OF PERFORMANCE FROM SGH TO SGLG

In CY 2012-2013, eligible LGUs were identified as all provinces, cities and municipalities that passed the Seal of Good Housekeeping or SGH. Starting CY 2014, SGH was scaled up into the Seal of Good Local Governance. As per DILG Memorandum Circular No. 2014-39 dated March 24, 2014, the SGLG supersedes the SGH that recognizes good performance of provincial, city and municipal governments on housekeeping and other areas that directly benefit the people.

As stated in the 2014 Implementing Rules and Regulations of SGLG, the 3 plus 1 principle shall apply before any LGU qualifies to the PCF. In other words, the LGU must meet the three core assessment areas of Good Financial Housekeeping, Social Protection and Disaster Preparedness, and at least one from the essential areas, namely, Business-Friendliness and Competitiveness, Peace and Order, and Environmental Management.



ELIGIBLE PROJECTS UNDER PCF

Each PCF subsidy shall be used for only one specific modular type of project to support any of the following:

- 1. Attainment of MDGs school buildings, rural health units or health centers, birthing or lying-in facilities, water and sanitation, and housing and settlements;
- Local Economic Development core local roads and bridges, farm-to-market roads, tourism
 facilities, irrigation systems, post-harvest facilities, cold storage facilities, ports and wharves
 and other economic structures and growth enhancement projects like markets and slaughter
 houses;
- Preparedness for Disasters/Adaptation to Climate Change flood control, reforestation, storm drainage, dikes, seawall and related flood protection measures and slope protection, evacuation centers, rainwater collection facility, early warning systems or rescue equipment;
- 4. Ecological Solid Waste Management sanitary landfill, material recovery facilities, sewerage system, and
- 5. Promotion of Transparency and Accountability website development.

PCF INCENTIVE PACKAGE

Financial subsidy to LGU beneficiaries are based on the following allocation:

EXECUTIVE SUMMARY OF ACCOMPLISHMENTS

PROGRESS REPORT

2010

Number of Beneficiaries

Thirty (30) pioneer LGUs received counterpart fund of P 30 million in 2010, with each municipality receiving P 1 Million. The roster was purely composed of $4^{th} - 6^{th}$ class municipalities.

Status of Projects

The P 30 million subsidized a total of thirty one (31) projects during PCF's first year of implementation. All 31 projects are complete (100%).

Distribution by Project Category

The distribution of PCF targets in 2010 per project category are presented as follows:


2011

Number of Beneficiaries

In 2011, 397 LGUs were given P 490 million to finance 618 projects.

Status of Projects

Out of the overall **618 projects** financed by PCF in 2011, **601** or 97% projects are fully **completed**. Fifteen (15) projects or 2% are still **ongoing** while 2 projects or 1% are still **complying** with PCF requirements.


2012

Number of Beneficiaries

In 2012, 560 LGUs received P 987 Million to fund 708 various projects.

Status of Projects

From the 708 projects generated by the 2012 PCF awardees, 651 or 92% projects are tagged as fully completed, 43 projects or 6% are still ongoing, whereas 14 or 2% of the listed projects are still complying with PCF requirements.



Distribution by Project Category

This is how PCF 2012 performed based on the four categories:

Medium development goals still led the pack with 339 projects, followed by local economic development projects at 303.


2013

Number of Beneficiaries

An aggregate of **734** LGUs were given a subsidy of P **990** Million to fund **488** local development projects in 2013.

Status of Projects

In terms of implementation, the 488 projects are distributed as follows: 86 PCF-supported projects or 18% of have been tagged in the PCF website as complete, while 108 or 22% are still ongoing and 294 or 60% of projects are still complying with requirements.



Distribution per Project Category

Medium development goal-related projects were down to 80 from the previous year of 339. While local economic development projects registered the highest of the bunch at 298, it's still six projects lower than PCF 2012's 303 projects under the same category.

2011

The 2011 GAA allocation of Php 500 million was apportioned in two operational releases: Php 490 million (98%) that subsidized 397 4th to 6th Class LGUs (all passers of the SGH Assessment), and Php10 million (2%) as implementation cost both for the central and regional offices.

2012

For FY 2012, the total PCF allocation was P1.003 billion based on GAA 2012. The PCF appropriation was P750M and P253M from DBM's Disbursement Acceleration Fund (DAF). P987M was allocated to the remaining 2011 SGH passers that belong to 2nd to 3rd Class. An additional P253M from the DBM DAF was allocated to augment the PCF to cover the remaining 1st Class Cities (19) and Provinces (28). The amount of P16M was allocated for the administrative/operational requirements of the PCF.

The distribution to 560 LGUs of the P 987 Million is as follows:

2013

In FY 2013, the PCF allocated P 1 billion from the 2013 GAA, of which Php 967 million was released on December 2013 to subsidize projects of 734 2nd to 6th Class LGUs (SGH 2012 passers). P 23 million was spent on typhoon Yolanda-affected regions per Department MC No. 2013-148 on December 2014 (*Table 5*). The two releases totaled P 990 million.

The approved budget of P 500 million per FY 2014 GAA is still being requested from the DBM to provide subsidy to the remaining 248 1st Class LGUs under the 2012 SGH which passed the GFH revalidation using the new Seal.

ACTIVITY REPORT

2012

Various activities such as consultation workshops were initiated by the Bureau, namely:

2013

With no assessment made in CY 2013, the Bureau devoted its time on continuing activities as it waited for (1) the release of subsidy to remaining LGUs mentioned above, and (2) the official list of the 2014 SGLG passers. Some of the project milestones of PCF 2013 include the following:

1,845 PROJECTS FUNDED BY PCF FROM 2010 - 2013

Overall, there are 1,845 projects funded by PCF from 2010-2013: 1,369 (74%) are completed, 166 (9%) on-going, and 310 (17%) still complying with administrative requirements. (from *PCF website, December 2014*)

1,721 LGUS RECEIVED A SUBSIDY OF P2.5 BILLION FROM 2010 - 2013

From CY 2010-2013, a total of 1,721 provinces, cities and municipalities have already received P 2.497 Billion as cash incentives for showing transparency and good financial management in their local governance.

PCF BUDGET ALLOCATION (WITH LGU COUNTERPART) CY 2010-2013




Table 1 shows a remarkable 156% increase in PCF budget allocations from 2010-2011, and from 2011-2012, the jump is more than double (100.5%).

Increasing Number of SGH Passers from CY 2011 to 2012




Table 2: The graph provides the number of SGH passers from 2011-2012 where increasing data suggests the eagerness of the regions to perform better to pass the assessment. Eleven regions showed a substantial increase with the number of passers. Region III demonstrated a remarkable increase from 22% passing rate to 84%.
