

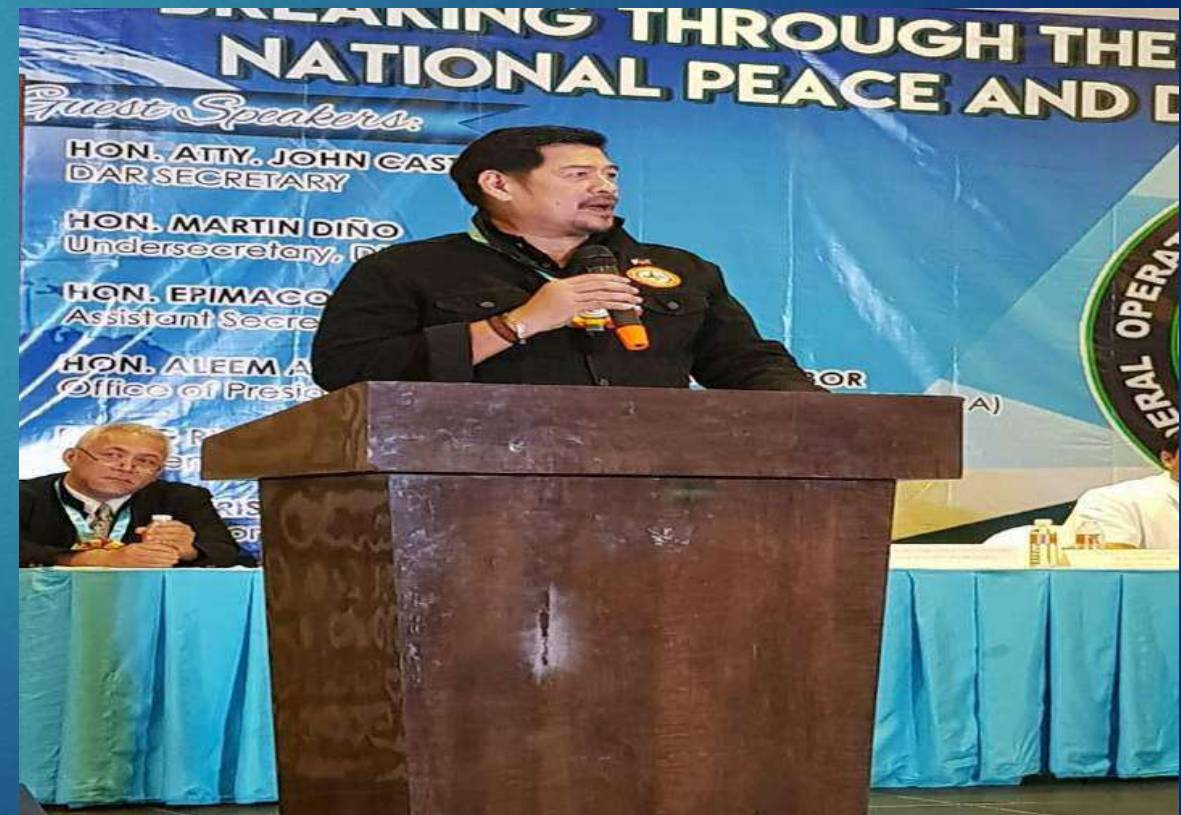

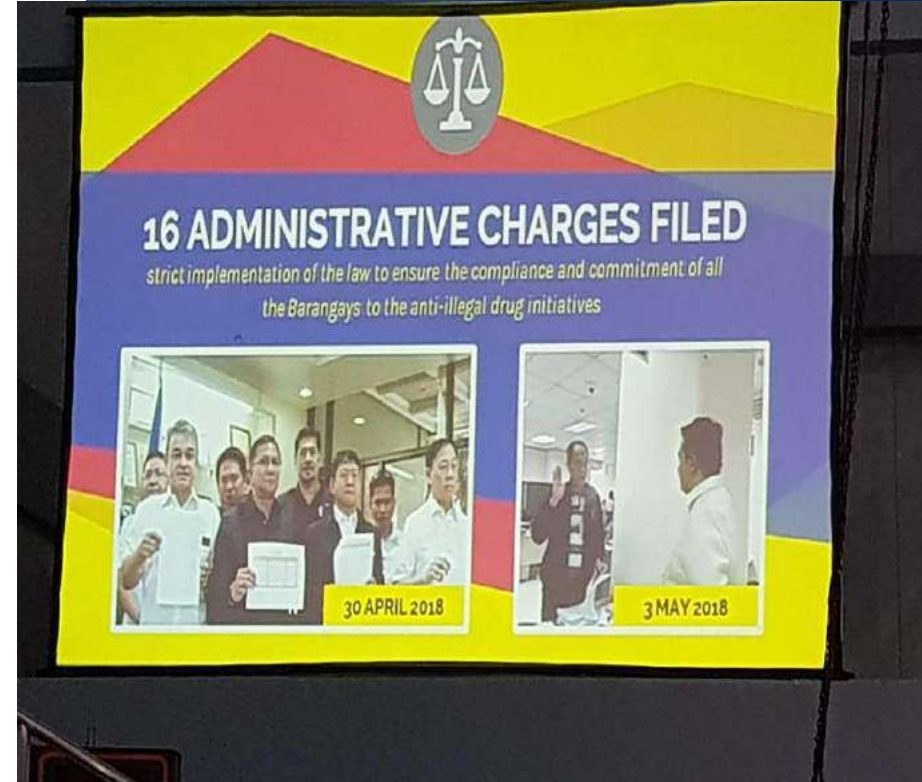
SUBJECT : GRANT OF AUTHORITY

In the interest of public service, the following Department Officials, alternatively, are hereby granted the authority, for and on behalf of the Department of the Interior and Local Government (DILG) to sign and file appropriate administrative complaints before the Office of the Ombudsman against concerned local officials for failure to organize functional Anti-Drug Abuse Councils in their respective local government units in violation of existing laws, rules and regulations, to wit:

- a. Undersecretary Austere A. Panadero;
- b. Undersecretary Martin B. Diño; or
- c. Assistant Secretary Ricojudge Janvier Echiverri

This Order takes effect immediately.

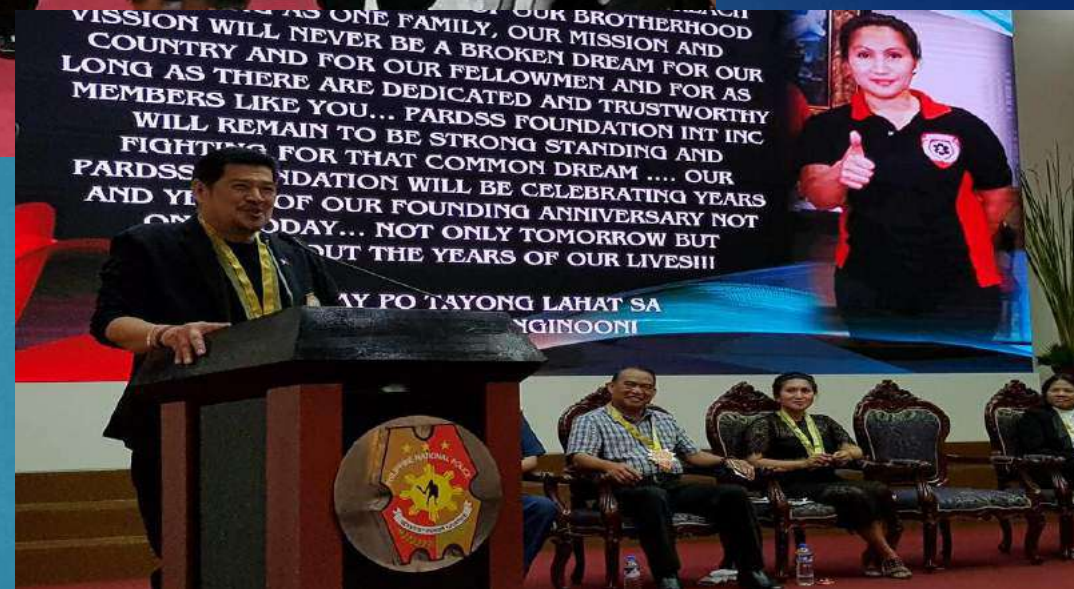

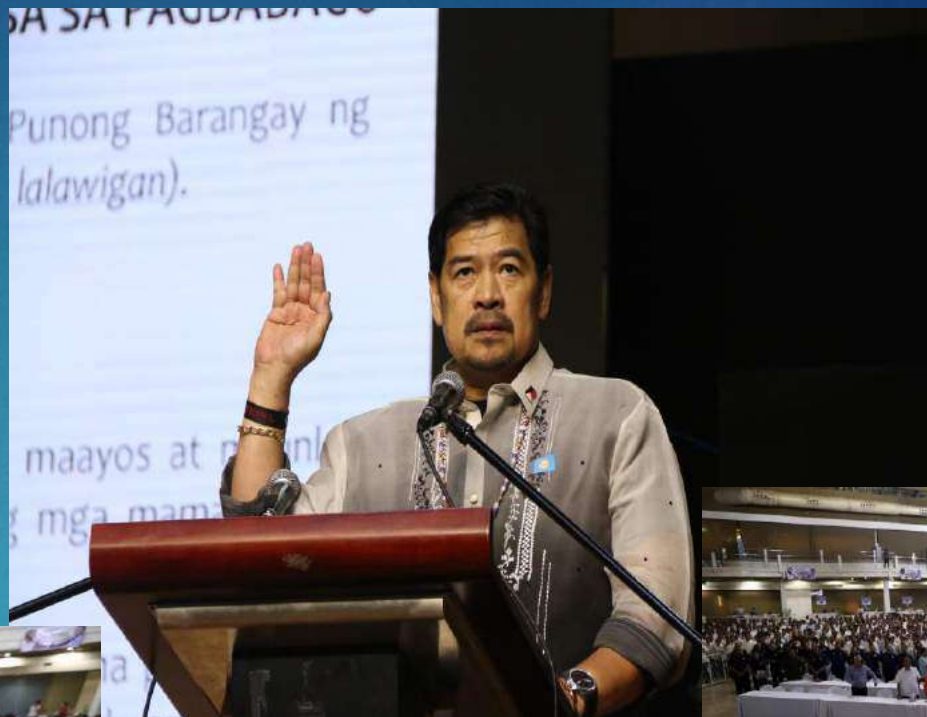
